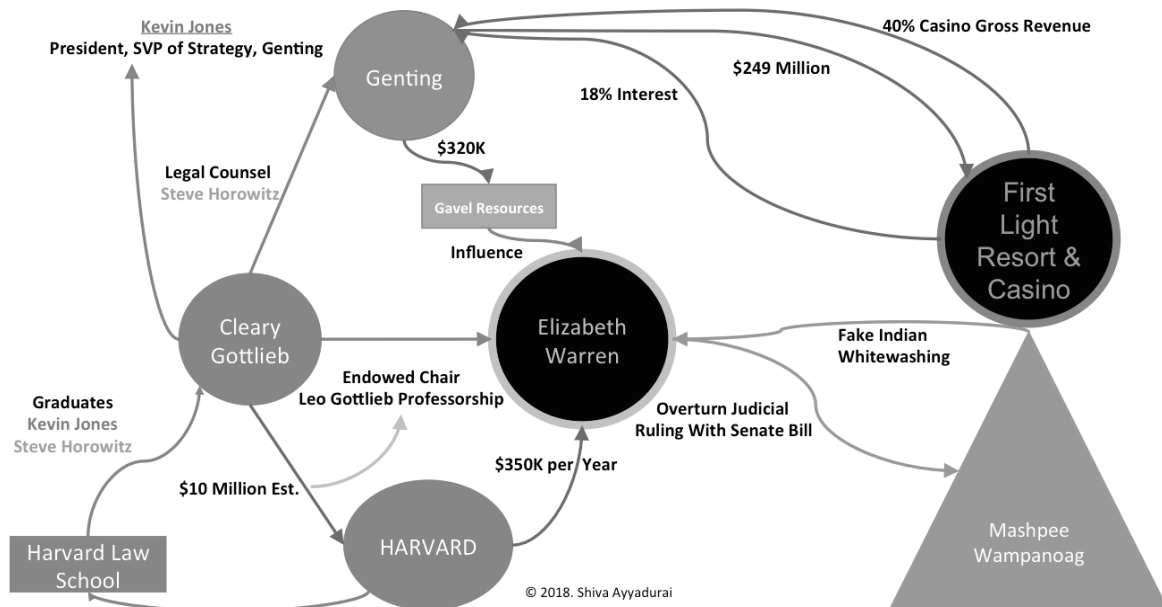
RE: Elizabeth Warren's Exploitation of Mashpee Wampanoag People. Harvard University Must Pay Reparations.

Dear Attorney General Sessions and Senator Chairperson Isakson,

I write this letter to call attention to a serious violation of ethics by Senator Elizabeth Warren, who has orchestrated a partnership to exploit the potential rights to land of the Mashpee Wampanoag people. Senator Warren's allies in this effort include: 1) Cleary, Gottlieb, Steen & Hamilton ("Cleary Gottlieb"), a law firm, headed by graduates of Elizabeth Warren's Harvard Law School, 2) Malaysia's Genting, a multi-billion casino empire, whose American subsidiary is led by Kevin C. Jones, also a Harvard Law graduate and former Cleary Gottlieb attorney; and, 3) Harvard University. What is particularly disturbing is that Elizabeth Warren's tenure at Harvard Law School, which she acquired by her false claims of being a Native American, was funded by an endowed Professorship paid for by Cleary Gottlieb.

The diagram below provides a visual framework to understand the network of insider connections that Elizabeth Warren has established to facilitate a bill in Congress to overturn a judicial ruling, with the main purpose of establishing herself, in the eyes of the public as a defender of the Mashpee Wampanoag ---- a "Real Indian" and not a "Fake Indian." I feel it is my duty to call on your honorable office to act and put an end to her actions, as it is the campaign slogan for my U.S. Senate run, "**Only a Real Indian Can Defeat the Fake Indian**" that has triggered her recent actions, in order to refurbish her image and exploit the Mashpee Wampanoag.

Elizabeth Warren's Network to Exploit the Mashpee Wampanoag People



Ms. Warren has organized this network to facilitate her career political objectives of maintaining her U.S. Senate seat in Massachusetts, which I have been working to oppose, and is under threat of loss, due to my relentless exposing of the fact that she is not a Native American. As the record shows, I gave her the opportunity to take DNA tests to prove her Native American heritage on three (3) occasions. Ms. Warren refused on all three occasions, in spite of my sincere efforts.

The current effort by Ms. Warren to exploit the Mashpee Wampanoag brings together a coterie of beneficiaries, who are reciprocally intertwined with seeing Ms. Warren's success in misrepresenting herself as an "Indian," as they are intent on extracting tens to hundreds of millions of dollars from exploiting the Mashpee Wampanoag. I therefore believe an investigation needs to be called immediately to conduct the necessary discovery and depositions to bring full transparency of these interconnections to the public.

I believe that the Mashpee Wampanoag have every right to land and the right to establish a casino to support their advancement; however, the current insidious model of exploitation, spearheaded by Ms. Warren only serves her interest and that of her partners.

The only real and ethical solution in this matter is for Harvard University to directly place \$1 Billion in escrow to: 1) Relieve the current debt of the Mashpee Wampanoag from the exploitative Genting, which is charging usurious rates of interest, 2) For Harvard to pay reparations to the Wampanoag people, who they have exploited for centuries.

This is only fair.

Harvard University has a history, dating back to the 1640s, of exploiting the Wampanoag of Massachusetts. By point of fact, in the 1640s, Harvard University, when on the verge of bankruptcy, used the Indians of Massachusetts to create a bogus “Indian College” to save Harvard from its financial mismanagement. In particular, as the record shows, they received monies from the Society for the Propagation of the Gospel in New England, to teach the Indians the Christian gospel. One brick building, the second in Harvard’s history, was built for the Indian College. However, only four (4) Indian students were ever educated and graduated. Harvard, in reality, used the monies and building resources to house its printing press and to educate White students.

Though nearly 400 years have passed, Elizabeth Warren continues the Harvard tradition of exploiting the Native peoples of the Americas. It is time that this end, and your kind intervention can bring justice to this legacy of exploitation; and, moreover, help to drain the sewer, in Massachusetts, the epicenter of which is Elizabeth Warren and Harvard, that feeds the swamp in Washington, DC.

Below are the details about the various parties involved in the exploitation of the Wampanoag people.

1. Elizabeth Warren

Senator Warren is now pushing a bill through the Senate, ostensibly to help the Mashpee Wampanoag tribe, to get them a casino, despite having consistently opposed casinos and gambling in the past. Her sudden flip-flop caught the attention of our campaign, and we looked into her actions to see if we could determine her motives. What started off as routine Opposition Research ended up uncovering shocking details of her liaison with foreign casino owners and their lobbyists along with a network of lawyers and lobbyists, most of them connected through Harvard University, who exploit Native Americans for their own benefit.

As you may know, Elizabeth Warren has opposed building casinos in the State of Massachusetts on the grounds that they cause economic hardship to a lot of people. Now, Warren has made a 180 degree turn, and is pushing a bill on behalf of the Genting group of Malaysia while packaging it as a bill to help the Native American tribe, the Mashpee Wampanoags. The Genting group has a history of lobbying and has worked in the State of New York with Governor Andrew

Cuomo. It is now using its clout and power, and has Elizabeth Warren behaving as its lobbyist in the United States Senate.

A look at the facts will show that the casino does not really help the Wampanoag tribe but uses their name to help the Genting family. Further, the identities of the network of people behind the casino project is truly shocking.

2. Cleary, Gottlieb, Steen & Hamilton (“Cleary Gottlieb”)

Kevin C. Jones, who is the President of Resorts World Massachusetts and Senior Vice President at Genting Americas, worked at Cleary Gottlieb. He was also Elizabeth Warren’s student at Harvard, and not coincidentally, Warren held the Leo Gottlieb Chair at Harvard Law School. It must be kept in mind that the Chair is named, when money is funneled into Harvard University. Harvard’s connection does not end there. Steve Horowitz, who once headed the Harvard Law Review, is the person at Cleary Gottlieb, who is now managing the case for Genting and he is an expert in real estate finance, and placing land into trust. There are many unanswered questions on the conflicts of interest between Cleary Gottlieb and its relationship with its leadership and alumni who represent Genting and are heading up Genting.

3. Genting Group

The Genting group will debt finance the casino at an exorbitant interest rate of eighteen-percent (18%). To date, \$249 million has been financed. The Genting group will get, in addition to the interest on the debt, forty-percent (40%) of the gross revenues from the casino. If the Mashpee Wampanoag people, get anything at all, it will be only an estimated 10 percent to 20 percent of the net income, while the Genting group will corner a minimum of 80 percent. It will be well worth investigating if this is what Senator Warren’s recent trip to Asia was about.

Evidence that the whole deal is improper can be gauged from the fact that Genting is the sole source of funding and there **were no Request for Proposals (RFPs) or bids put out to other casino operators --- a practice, which is the standard procedure before such projects are executed.** A previous attempt to set up the casino was struck down by the judicial branch, and Warren’s U-turn to use the legislative branch to overturn the decision of the courts is worth an investigation all by itself.

In addition to all the above points, since Genting uses lobbyists and indirectly funds crooked politicians like Elizabeth Warren to help refurbish her Fake Indian image, I request that Genting be penalized for not registering themselves as a Political Action Committee (PAC).

Warren’s intervention will benefit Genting, which will likely lose nearly \$300 million, if the land is not allocated to the Mashpee Wampanoag’s.

4. Harvard University

As can be seen from the facts described above, Harvard University is at the center of this scheme. Harvard University received an estimated \$10 million endowment from Cleary Gottlieb to setup the Leo Gottlieb Professorship. Elizabeth Warren was the beneficiary of this Professorship, as she received \$350,000 in annual salary from this endowed Chair. Harvard University and Elizabeth Warren have yet to disclose their conflicts of interest. Harvard receives federal funding and should be investigated along with the other parties mentioned in this letter.
